JOSE D. AVELINO FACT SHEET

AVELINO LEGACY (Copied from other sources with no copyright infringement intended)

- Sponsored Republic Act 328 Creating the City of Calbayog in Samar
- Founded the first labor union in Eastern Visayas called Gremio Obrero de Stevadores de Calbayog (now Gremio Services under the Anak Pawis Labor Umbrella)
- Founding Member of the Liberal Party along with Presidents Manuel Roxas and Elpedio Quirino
- Unified the Labor Unions by organizing them into two (2) Commissions with Avelino serving as Chairman for both:
 - >>>National Commission of Labor (NCL)
 - >>>National Commission of Peasants
- Found the first political party in Calbayog City, Liga de Calbayog
- Authored the Philippine Compensation Law
- Initiated the Law bringing High Schools to all the public elementary schools in the Philippines
- Advocated the equality of rights between husbands and wives and allowing wives to transact and negotiate business without the husband's consent
- Filed a bill that provided for the purchase of large landed estates and their distribution to the landless free of charge; the other bill provided for the confiscation of all properties and assets acquired by government officials thru questionable means during their term in office
- Founding Member of the University of Eastern Philippines (UEP) in the Catarman, Northern Samar, the first state university in the Visayas.
